

Fact Sheet 59 Basic BCW Metrics 2017 November 10, 2017

Jefferson County compiled some basic Bear Creek Watershed metrics for use in the development of a Total Maximum Daily Load Model for the watershed using 2017 GIS data.

Bear Creek Watershed total area: 236.5 square miles and includes:

- Federal Lands: 61.4 sq. milesState of Colorado: 6.8 sq. miles
- Denver Mt Parks: 14.5 sq. miles
- Metro Districts: 9.1 sq. miles
- Water & Sanitation: 7.6 sq. miles
- County/Other: 137.1 sq. miles


